Part I.

A. This vessel participated in the Musketeer Mike ONE Operation as a part of the San Fabian Attack Force, Blue Beach ONE, S-day section, departing Hollandia, New Guinea 17 December 1944 and arriving Sansapor, New Guinea on 20 December 1944 for loading and rehearsal. Rehearsal conducted 23 December 1944. Underway 30 December 1944 for assault area carrying TWO 2x30 pontoon causeways, ONE LVTA(1), TEN LVT4's assault troops of the 6th Infantry Division U. S. Army and miscellaneous vehicles and bulk cargo. Anchored at 0750, 9 January 1945 in assault area, launched LVT's and pontoons. Beached at 1238 same date with pontoons alongside. Rigged causeways. disembarked vehicles and bulk cargo, retracted at 0530, 10 January 1945. Underway from Lingayen area 11 January 1945, returned to LEYFE, P.I., arriving 15 January 1945 to load for Mike 1 reinforcement. Loaded at Catman Hill Beach 18 January 1945 with vehicles, cargo and troops of 32nd Infantry Division U. S. Army. Underway 20 January 1945 enroute Lingayen. Arrived 27 January 1945. 29 January 1945 beached at White Beach 2, Lingayen and unloaded. Released from Mike 1 Operation upon completion, underway on 30 January 1945.

Part II.

A. This vessel operated as a part of S-day section (8 LST's) of T.U. 78.5.5 (29 LST's) of the Blue Beach Attack Group, San Fabian Attack Forces under CANF SWPA operating under order #17-44, Commander Task Force 78 operation order #103-44, and Commander Task Group 78.5 attack order #2-44.

- Operations of this unit from leaving Hollandia were routine. Attack rehearsal held on 23 January 1945 in Cape Omarai section of New Guinea. AA gunnery drill at burst targets held 31 December, 1 Jan and 2 January.
- C. Primary mission of this vessel to land 11 LVT's on Blue Beach in conjuction with assault waves from other LST's and transports of the Blue Beach Attack Group. Plans and assumptions as in Task Group 78.5 Attack Order #2-44. Secondary mission to proceed to LEYTE, embark reinforcement units and land them in the Lingayen area.
- D. Own Force as in Task Group 78.5 Attack Order #2-44.
- E. Enemy forces encountered. Surface, None; Aircraft, THREE ZEKES identified in daylight raid of Jan. 8. Very sporadic attacks on this formation at other times with no direct attacks on this vessel.

0246 General Quarters. 0759 3 Enemy aircraft dove into convoy from cloud cover, one crashing into stern of Callaway, AA fire ineffective against others. 0909 Secured from General Quarters.

9 January 1945:

0620 General Quarters. 0750 Anchored in inner LST area, Blue Beach. 0800 Assault personnel embarked in LVT's. 0805 Launched LVCP's ONE and TWO to act as wave guide boats. 0811 Launched LVT's with assault personnel. 0920 Launched starboard pontoon. 0931 Launched port pontoon. 1031 Secured both pontoons along starboard side. 1143 Underway proceeding to beach. 1238 Beached on Blue Beach ONE. 1310 Rigged pontoon causeways, commenced discharging vehicles and cargo. 1310 KATE approached from 005(T) distance 5000 yards, commenced fireing. 1312 Ceased firing. 1900 Unidentified, type unknown, enemy aircraft sighted 170(T) distance 6000 yards commenced firing. 1903 Ceased firing. 2200 Set condition 1-Easy.

B. Weather for assault convoy and S-Day was excellent. On S-Day, wind averaged THREE knots, temperature 80°F, few clouds, and excellent surf conditions on Blue Beach.

Part IV. ORDNANCE:

- A. Ordnance equipment this vessel consists of 20MM and 40MM automatic weapons. Performance was excellent. Fire discipline was fair showing improvement. Effectiveness difficult to judge because of few targets presented this vessel, but failure to lead target was noticed, particularly in the 20MM battery. Ammunition expended during entire operation, including training 289 40MM; 2,472 20MM.
- B. No opportunity was presented to witness the operation of enemy ordnance.

Personnel performance was excellent. Men carried out their assigned duties in a workmanlike manner in spite of inexperience. No casualties were suffered. Part VIII. LESSONS LEARNED, CONCLUSIONS AND RECOMMENDATIONS. Inasmuch as this was the first operation in which this vessel took part, and the first time the

been in action, the lessons learned were numerous. The value of strict fire control and training in "Leading the target" was clearly imphasized in the few targets presented this vessel. Handling of troops aboard. Handling of pontoon causeways and their use in loading, handling LVT's all acted as lessons for the crew and officers of this vessel. Much was gained that will make future operations run smoothly.

Major difficulty was encountered due to overheating of auxileary dengines, as pontoon causeways blocked the exhaust of these engines to a very great extent. It is recommended that vessels carrying causeways and barges be provided with a deck exhaust for these engines making far more efficient operation and gaurding against sudden loss of power due to over heating.
