1. This vessel left Morotai Anchorage, Halamahera Is. at 1435, in accordance with C.T.U. 78.1.16 SADAU Landing Directive, serial 0001 of 24 April 1945, derived from Commander Amphibious Group SIX Attack Order No. A 604-45, in company with T.U. 78.1.16. Schedule to objective area was maintained. C.T.U. 78.1.16 was transferred aboard this vessel at 0625 Item, 30 April 1945, from U.S.S. PHILIP (DD 498) and at 0712 this command reported on station as Landing Craft Control vessel for Sadau Landing. Landing was successfully completed prior to departure at 0920 for Yellow Beach, (LINKAS). At 1030 this vessel reported on station as Landing Craft Control vessel for P-1 Day Demolition Operation. Demolition of beach obstacle was successfully completed by 1630. At 1638 C.T.U. 78.1.16 transferred to U.S.S. PHILIP (DD 498), and this vessel proceeded to withdraw from harbor with T.U. 78.1.16. In the vicinity of Point "Whirlaway" C.T.U. 78.1.16 released this vessel at 0125 and directed it to take station with Echelon O-1-F.

2. No enemy was contacted by this vessel during the operation. No rounds of ammunition were expended.

3. All elements of this command performed capably, and satisfactorily.




