PART I GENERAL NARRATIVE

1. The operation in the Manggar-Balikpapan area of eastern Borneo was based on Commander Allied Naval Force, SWPA. Operation Plans 8-45 and 11-45, CTF 78 (Com7thPhib) Operation Plan 12-45, and CTG 78.2 (ComPhibGrp8) Operation Plan 6-45. CTU 78.2.5 (ComLSTFlot22) issued serial 0006 dated 22 June '45 which amplified and clarified CTG 78.2 OpPlan 6-45 as it applied to TU 78.2.5.

CTF 78, Vice Admiral D. E. BARBEY, was Attack Force Commander. CFG 78.2, Rear Admiral A. G. NOBLE, was designated Commander of the Attack Group. Commander LST Flotilla THENTY-TWO, Ceptain F. J. MRE, was designated Commander of the LST unit by reference (b). The LST unit consisted of 35 LSTs, 19 of which participated in the F Day (1 July) operation as TU 78.2.5 under command of ComLSTFlot22. Of the remaining 17, 14 are to arrive at the objective area as TU 78.2.35 under command of ComLSTFlot7 on F plus 2; 3 on F plus 5, or when called.

elements of the SEVENTH Australian Division and supporting forces consisting of the 18th, 21st and 25th Brigades, at Merotai and transport these troops and their equipment to the Manggar - Belik-papan area of Borneo in accordance with the Movement Plan, Annex B to reference (b). These assault troops were to be landed at H hour, 09001, on F Day, 1 July, on Red, Yellow and Green beaches in accordance with the Landing Plan, Annex C to reference (b). The 18th Brigade was landed on the left flank; the 21st Brigade on the right flank; the 25th Brigade was held in reserve. Upon completion of unloading, this unit was to depart from the objective area and return to staging areas to reload and return to the objective area in accordance with the Convoy Plan, Annex B, of reference (b).

TU 78.2.35 is to lift reinforcement elements at Morotai for

the objective area, arriving there on F plus 2.

LST unit on 13 June. ComLSTFlot22 was relieved by ComLCIFlot7 as CTG 76.13 (Com7thPhibRepMorotai) on 19 June. From 13 June until 26 June, the LST Unit Commander was engaged in preparing and loading the LST Unit 78.2.5 for the operation. LSTs of TU 78.2.5 began loading on 17 June at Blue Beach, Morotai and completed loading on 22 June. At 14001, 23 June, TU 78.2.5 departed Morotai in convoy with CTG 78.2 on Wasatch (AGC 9) as OTC for rehearsal of the assault phase of the operation. This rehearsal was held on the morning of 24 June on the beach near Miri River on the southeast coast of Morotai. The LVTs which were transported by

LSTs 632, 397, 452, 454, 457, 639, 694 and 777 were launched and landed. The assault waves made the run to the beach, but were not landed. The LSTs beached to reload the LVTs. LST 397 evacuated 5 natives, who were injured by the support fire during the rehearsal, to Morotai.

A conference of all Task Unit Commanders and Commanding Officers of TG 78.2 was held on board the Wasatch on 25 June. The flaws noted in the rehearsal were pointed out and all phases of the coming operation were discussed. CTU 78.2.5 held a conference of all Group Commanders and Commanding Officers of TU 78.2.5 on morning of 26 June. Errors in the rehearsal and difficulties to be expected in the operation were pointed out.

at 14001, 26 June 1945. After all units were clear of the harbor, Cruising Disposition No. 1 was formed and the assault group proceeded to the objective area in accordance with the movement plan. At 0554I on 1 July 1945, upon reaching a predetermined point, a signal to Deploy was executed by CTG 78.2 at which time the LSTs stopped to cast off tows. All tows were cast off by 0616I and the nine LSTs for Area Baker proceeded in company under the command of CTU 78.2.5. The ten remaining LSTs proceeded to Area Able under the command of Commander, LST Group 23.

The Area Baker LSTs anchored in Area Baker at 07461, H-74. CTG 78.2 confirmed H hour, 09001, as scheduled. Immediately upon anchoring LSTs 397, 632 and 639 launched wave guide boats and embarked wave guide officers for the first wave of 37 LVTs. LSTs 452, 454, 694 and 777 furnished wave guide officers and

boats for the second wave, consisting of 54 LVTs.

At 0807I the first and second waves departed from Area Baker enroute to line of departure. LST 457 furnished guide boats and officers for the 16th wave of 16 LVTs. The remaining LSTs furnished boats and wave guide officers for troop waves in accordance with the boat employment table, Annex C of reference (b). The first wave landed on the beach at 0855I, 5 minutes ahead of H hour; the second wave at 0857I.

No resistance was encountered by the first waves. At 0920I, the Laton (DD 510), 1500 yards to starboard of LST 632, was observed to be under fire from shore. At 0959, the boat lanes for

each beach were under fire.

Since the beaches were unsuitable for beaching LSTs, it became necessary to unload them into LCTs and LCMs. This had been provided for in the literage bill. The ramp to ramp unloading into LCTs proved difficult, laborious and dangerous due to the heavy swells. The ramp to ramp unloading into LCMs under the same conditions of sea was accomplished without difficulty. Although at most times there seemed to be a plentiful number of LCMs milling around in the LST unloading area, there were far too few actually engaged in unloading. When the decision was made to continue unloading during the night, representations were made to the Landing Craft Control Officer to send only LCMs to the LSTs during the night. Reports indicate only one LCM reported to the 19 LSTs from 2200, 1 July to 0700, 2 July 1945. As a result of the difficulties mentioned the first LST turnaround scheduled for the evening of target date was delayed twenty-four hours.

At 1745I, LSTs in Area Charlie were under fire from shore. The Conway (DD 507) silenced the fire. No damage or casualties were suffered by LSTs. Unloading into LCTs during the darkness

was next to impossible.

At 11221, 2 July, Area Charlie was again subjected to fire from shore. There were no casualties or damage to LSTs.

LSTs 397, 452, 454, 457, 632, 639 and 694 were unloaded and ready to sail in Convoy 02-U at 1830 on 2 July.

All pontoon barges were unloaded. LSTs 721, 935, and 938 did not unload ponteon causeways.

- (b) That when heavy swells are encountered LCTs be used only during daylight hours in the ramp to ramp off loading of LSTs.
- (c) That LCMs be used in preference to LCTs.
- (d) That LOMs remove their "living quarters" to provide more literage space.
- (e) That the officer in charge of LCMs take station in the unloading area to assure that LCMs are gainfully employed at all times.

 - (e) Proper supervision of lighterage is essential, the physical location of the officer-in-charge of LCMs is dependent upon local conditions and should not be arbitrarily designated.
